Thank you for choosing Sonera Payment Terminal Service!

Before we can deliver a ready-to-use payment terminal, you must do the following:

1. Print these instructions and take them with you when you go to your bank to make a new payment terminal agreement.
NB: A separate payment terminal agreement with your bank is required for each Sonera Payment Terminal.
2. You must also sign the necessary agreements with credit card companies.
3. Register the agreement information you have received from the bank and credit card companies.
 - Register the information through www.sonera.fi/maksupaate/hallinta.
 - You need an SMP identifier for the registration.
 - Check that all registered information is entirely correct. You are responsible for the accuracy of the information you provide.

The information will be provided to Point Transaction Systems Oy, which will install the payment terminal so that it is ready to use based on the information you have given. Point Transaction Systems Oy serves as Sonera's partner in the Sonera Payment Terminal Service.
